TPSS STATEMENT OF COMPLIANCE - In compliance with Louisiana R.S 17:235-2 (grades 1-12) and the Every Child Succeeds Act (ESSA) of 2015 relative to commitment by school students and their parents or guardians, the Tangipahoa Parish School System has written a signed statement of compliance as required by law. This compliance statement is in regard to school attendance, homework assignments, and school rules.

**A. STUDENT AGREEMENT:** As a student, I will do the following:

- I will abide by the student code of conduct, acceptable use policy and academic honesty policy. If I fail to abide by the school and district policies, there may be a conference to discuss my learning model placement.
- I am aware that cheating, allowing others to complete my work, using unauthorized websites for answers, and submitting work that is not my own will result in a possible conference to discuss my learning model placement.
- I will complete all assignments in accordance with the scheduled due dates.
- I will need to come in for test proctoring, tutoring, or other activities as designated by the school.
